Program Updates



Haiti Reborn

After wrapping up the internal aid project, called *Yielding Change*, in the wake of the 2016 Hurricane Matthew, our attention returned to the immediate needs of our friends in Gros-Morne. With your support, they are transforming the world around them. The Jean Marie Vincent Formation Center continues to manage the tree nursery and reforestation projects. New projects include agricultural training and assistance, and community poultry and live stock programs. The reforestation project is stabilizing the ecology of Tet Mon and mitigating the effects of storms. Other agricultural programs are increasing families' food supply and ability to earn cash income.

We were heartened to see our partners, and most of the is land nation, relatively unharmed in a terrible hurricane season last year. Never the less, there has been a continued issue with cholera brought to the island by the UN mission after the 2010 earthquake. We rejoined our friends at the Haiti Advocacy Working Group to urge policies more favorable to Haiti. Our strongest emphasis, in this regard, is to advocate for policies supporting the right of Haitians living in the United States to remain and seek permanent residency.



Quest for Peace

Our delegation to Nicaragua on November 7-13 brought together three of our staff – Dolly, John, and Mfon – with three members of the Quixote community. We got to know some of the agroecology projects of FEDICAMP up close and personal in a rural community in the Segovias. The trip allowed us an opportunity to see firsthand the fruits of the Homes of Hope initiative. Quest supporters have raised over \$1.4 million toward our goal of \$2 million to finance the construction of new housing. We traveled to construction sites and finished housing in León, Sébaco, and Managua and spoke to the families living in those homes. We were also able to visit additional project sites of our long-time partner the Institute of John XXIII.

At the same time, our opposition to the NICA (Nicaraguan Investment Conditionality) Act continues. The NICA Act would require the Trump administration to block loans and development assistance from international organizations to Nicaragua. Although this legislation has already passed the House and has bipartisan support in the Senate, we believe it will fail in achieving its stated goals of improving democracy and reducing corruption in Nicaragua. It is likely to cause a humanitarian crisis and possibly a new wave of economic migration by shutting off international funding essential for health, education, and infrastructure programs. Ouest for Peace has long been opposed to U.S. intervention in sovereign foreign nations with elected governments. We will continue our efforts to provide information on this important legislative issue.

Temporary Protected Status

Since 1990, the United States has offered Temporary ProtectedStatus(TPS) to people from countries devastated by war or natural disasters. The Trump administration is currently refusing to extend this protection for the largest groups of recipients: Salvadorans and Haitians. The implications of this action are devastating for the individuals and the countries involved. After an initial blog post in June, we launched a full series on the topic beginning in September. We are mindful that this issue remains unresolved, but we believe that a robust TPS program grounded in justice would offer a path to residency and citizenship for its participants.

Program Updates

Catholics Speak Out

CSO wrapped up the Bibles to Bishops program in the first quarter of 2017. This year we begin a process of creating new editions of our inclusive language publications, incorporating editorial corrections and updating translations in places. We have begun to organize a team of loving readers to carry out this work. Would you care to join us?

We prepared a prayer and action resource on Inclusive Citizenship as well. The body of Christ is about radical inclusion and so we advocate for a world in which native peoples, migrants, trans persons, prisoners, and so many others who are excluded from full participation in the social and political realms around them, will be welcomed. The resources are available on our website for use in community events.

The Quixote Center remains active in the coalitions Catholic Organizations for Renewal and with our friends at Call to Action (CTA). At the CTA Eastern Region Conference this fall, we showcased our inclusive language publications, remaining an active voice for women's ordination and fundamental equality for all within the church.

Criminal Justice

Over the last year we have entered into a period of research and reflection on the next steps for the Center's work toward a new justice system. We continue to assist people who are incarcerated, as well as their families, through distribution of the Capital Defense Handbook. We have been reaching out to connect with various organizations through conferences, special events, and one-on-one phone calls. We were inspired to be in a packed room on Capitol Hill to discuss criminal justice reform as part of the Congressional Black Caucus' Annual Legislative conference. In addition, we have written engaging blog posts on topics such as the "taking a knee" protests undertaken to shed light on police brutality, and the provision of military surplus armaments to local police.

Friends

Though the Quixote Center has never been a relief organization, sometimes when a friend is in need, immediate help is the thing to do. We sent support for public universities to our neighbors in the U.S. Virgin Islands and Puerto Rico this year to help them rebuild after the brutal Hurricanes Irma and Maria. We also sent aid to Houston to support organizing efforts after Hurricane Harvey.

We celebrated life in a variety of ways last year, but parties were certainly part of that story. In July, we had an event in Hyattsville, Maryland where the new faces at the Quixote Center – John and Mfon – got to meet faithful friends of Quixote. In September, the team took the show on the road for a party in Philadelphia, hosted by Quixote Center's Vice-Chair Noelle Hanrahan of Prison Radio. She and all the other members of the Quixote board were in attendance, as was Loretto Volunteer Jocelyn Trainer and the rest of the team. We closed out the year with a Christmas party at the Center, where former staff such as Maureen Fiedler of Interfaith Voices and Jeannine Gramick of New Ways Ministry joined us to celebrate another year of working for justice.

Quixote Center Reunion

All former and current staff, volunteers, interns, donors, supporters, friends and family are invited to join us on **Friday**, **April 13** to celebrate the Quixote Center community. We will gather at the Marriott in College Park for an evening of reflection and music. New York City Mayor Bill de Blasio and other Quixote Center alumni have been invited to share their stories.
